**Rules For Cart Privileges**

1. \$200.00 Storage Fee pays for cart storage privileges from May 1, 2024 through April 30, 2025. You must also be a current paid golf member at PRGC and have paid the \$125.00 Trail Fee to obtain cart storage privileges.
2. All personal carts stored at PRGC MUST pay the storage fee and be stored in a PRGC cart barn as long as there is storage space available. No personal carts can be stored outside at PRGC if there is cart barn storage space available.
3. Individuals that wish to trailer their carts to and from PRGC will be charged a Daily Trail Fee of \$5.00. Non-members will also have to pay the daily-posted greens fees for that day.
4. \$325.00 Storage & Trail Fee entitles cart members to name up to two (2) individuals as drivers for their cart. Additional drivers are required to pay the Additional Driver Fee of \$100.00 each. Note –Student & Dependent Members of current paid golfing members are allowed to drive their parent, grandparent, or guardian (s) carts under the \$325.00 Storage/Trail Fee.
5. All cart Storage & Trail Fees MUST be paid by May 1, 2024 or your cart will be removed from the PRGC cart barn.
6. It is the responsibility of cart members to keep their area of the cart barn clean.
7. All individuals storing their carts in either one of the barns MUST sign and date this agreement acknowledging that they have read and agree with the cart rules of PRGC.
